

- (g) To provide Medical assistance to the poor and weaker sections of the society and rehabilitation services to children/persons with special needs.
- (h) To receive, hold and suitably use and fees, funds contributions, bequests or endowments or the proceeds thereof of the trust for fulfilling its aims.
- (i) To function as a data bank on education and to establish information and counselling centers.
- (j) To undertake reparation and publication of materials including journals and other periodicals and preparation and dissemination of materials for mass media.
- (k) To establish centers, libraries, book bands, Understanding forum and Inter-faith Dialogue Forum to promote Communal Harmony among diferent Religious communities and group the society.
- (l) To acquire, establish, constuct, maintain, manage and supervise, Fellowship centers and subscribe to arrange for training centers, Camps, Workshop, seminars, Excursions, Study groups, Recording studios and other ancillary services for the members and general public to further the purpose of this Organisations.
- (m) To undertake specific programmes fo poverty alleviation, self-employment etc. Also, to establish and maintain counseling center for job opportunities.
- (n) To undertake and work on such projects of general concern for himanity as pollution and ecology etc and to organize Movement, counseling centers and other forums to bring about public awareness of the illls of Drug abuse, AIDS, Crime and other Social evils like Dowry systems etc.
- (o) To establish institutions of comparative studies of religions and Forums for Religious Understanding and Dialogue.
- (p) To organize field for the propagation of peace among different religious communities and creating human brother-hood among them.
- (q) To establish forums of 'Serva Dharm Ekta' (Iner-faith unity), 'Ratriya Ekta' (National unity) and all peace communities.
- (r) To establish, administer and maintain such premises as required for public covenience like Dharmshala, Vidhva ashram, Gaushala etc.
- (s) To quire, establish and run homes for the support of children rendered destitute in communal clashes, natural calamities and other causes without any discrimination of religion, creed and caste.





- (t) To aquire, establish, construct, construct, maintain, manage and supervise special schools, collages, rehabilitation centers, vocational training centers and parental assistance centres for intellectually and physically disabled persons of the society.
- (u) To undertake relief measures in aid of the distressed people affected by Natural calamities, communal Riots or in other-ways e.g. to rehabilitate them and make them self-dependent through income-generating schemes.
- (v) To undertake Integrated Rural Development Projects for over all socio-economic development of the villages including encouragement of co-operative movement among the villagers.
- (w) To establish and run financial institutions to fulfill the Aims and Objectives of the trust.
- (x) To undertake all such activities as are not specially mentioned in the Aims and Objectives listed above but which promote these objectives.

IN PURSUANCE OF THE ABOVE OBJEVTS, THE TRUST MAY :-

- (a) Aquire by purchase, lease, mortgage, will, gift, grant, legfacy bequest, exchange, right, privilege or otherwise from any person, company, society, Government, institution organization or anybody whatsoever, moveable or immoveable properties of description deemed necessary or useful for any purpose of the trust.
- (b) Aquire free building or structures whatsoever to further and purpose or purposes of the trust and to maintain, alter, demolish or reconstruct the same or any portion thereof.
- (c) Take or receive any gifts, whether money property, movable or immovable, donations in the form of debentures, stocks, shares or securities in and company or society whether in corporate or not or whether by gifts by a person living or by legacy bequests, will or foundation and whether subject to and special trust or for works connected therewith and to take steps for the securing of such contributions for funds as from time to time be deemed expedient.
- (d) Alienate by way of sale, mortgage, lease, release, loan, charge, hypothccation, pledge, exchange hiring out, gift or otherwise with or without security of properties or contributions, assistance, peruniary or otherwise to such institutions, bodies or person as form time to time deemed necessary or expedient.
- (e) Lend money free of interest, invest, lay aside, deposit in bankor otherwise deal with moneys of fund of the trust not immediately required for the objects of the Trust and to subscibe or purchase, acquire, hold, sell, endorse and negotiate in debentures stock, shares and securities of every




- (f) Borrow or raise funds with or without security in any manner the Trust may think fit and repay the same.
- (g) Nagotiate with and enter into arrangements with and Government, Autherty, Corporation, Board, University or other public or private bodies as may seem conducive to the promotion or accomplishment of the objects of the Trust or any one or more of them and to apply for obtain. collect, receive such grants loans allowances, rights, consessions and privillage as may seem to comply with the objects and utilize the same.
- (h) In general do or cause to be done apart from all the acts state above, all such other acts or things as shall be conducive to the interest of the Trust provided that such things or acts be not contrary to nor inconsistent with the spirits and principles of law under which the Trust has been established.

2- MOREOVER

- (a) The funds of the Trust shall be invested in the mode specified in the provisions of section 13(1) read with Section 11 (5) of Income Tax Act 1961.
- (b) No amendments to the Trust Deed/Memorandum of association and reles and regulation shall be made which may prove to be repugnant to the provisions of Section 2(15), 11, 12, 13 and 80(h) of the Income Tax Act. 1961. Further no amendments shall be carried out without the prior approval of the commissioner of Income Tax.
- (c) The funds and the income of the Trust shall be solely utilized towards the achievement of the objects and no portion of it shall be utilized for payment to Trustees by way of profit, interest, dividend etc.

3- BOARD OF TRUSTEES :-

There shall be these (3) Trustees initially. The Founder Trustees shall form the board and be the Trustees for life. The trustees shall be elect amongst themselves a Chief Trustee and two member of Trustees. The board of Chief Trustee has been hold all Trust responsibilities (as Presidentship, secreteryship and Treasurer etc.) and Tow member of Trustee shall be ever co-operative of board of Turst's activities. In case of a vacancy caused by death, resignation or otherwise, the remaining Trustees may fill up the vacancy co-opting any other person as a member of the board of Trustees within a period of four



4- MEETING

The Board of Trustees shall meet once in two months to transact business of the trust. Five days notice shall be given of such Meetings. the quorum for the meeting shall be two Any two Trustees may in writing, requisition the chief Trustee to convene a Meeting of the Board of Trustees clearly indicating the subject matter to be discussed. On receipt of such a requisition, the Chief Trustee shall call for a Meeting after giving five days notice. The Chief Trustee conence a meeting by given notice of five days to clear to other Trustees and the decision taken at such a meeting shall be valid and binding provided that at least tow of Trustees attend such meeting and the decision is passed by the majority. The Chief Trustee as presiding officer shall have a casting vote in case of equality of vote. Notice all meeting shall be sent by ordinary post under certificate of posting or through a courier service. If, however, in the opinion of the chief Trustee, the calling of a meeting of the Trustees is impracticable for any reason to be recorded in writing, the chief Trustee may get opinion of the Trustees by circulating the files concerned on the subject matter and place them before the chief Trustee, who shall take a final decision keeping in a view, the opinion of majority of Trustees.

5- POWERS OF THE BOARD OF TRUSTEES :-

The Board of Trustees shall perform and exercise the following acts, deeds and power :-

- (a) Demand all moneys payable and receivable by the Trust and give effectual receipts and discharge for the same by them selves jointly or through their accredited agents.
- (b) Condoct or defined or comprise legal actions, appoint legal advisors for conducting or legal proceedings and to perform all such acts, indental to them by themselves or through their accredited agencies.
- (c) Excute all documents related to the immovable properties or to any loan, aids, secured or obtained.
- (d) The trustees shall enter into contracts or arrangements with third parties as may be decided upon by the majority of Trustees in writing at a meeting duly called for the purpose.





- (e) The Trustees shall act jointly and if any difference of opinion arises at any time among them in relation to the doing or forbearing to do anything or otherwise, the opinion of the majority shall prevail and shall be binding and shall be effectually carried out.
- (f) The Board of Trustees may delegate any or all their powers to any one or more of them for such time and purpose as they deem fit.
- (g) The Board of Trustees is fully empowered to carry out the aims and objectives of this manner it deems fit.

6- THE MANAGEMENT :-

The management and control of the properties and affairs of the Trust shall be vested in the Board of Trustees. The Trustees by themselves or through an agent or agents employed by them manage or deal with the Trust property.

7- FUNCTIONS :-

- (a) **The President :** The Chief Trustee shall be president of the Board of Trust. In any case, Chief Trustee has all power trust. the chief Trustee shall be select president any member of Trustees.
- (b) **Secretary :** The Chief Trustee shall be secretaryship responsibility. He shall be in charge of and responsible for the safe custody of all records relating the administration of the Trust and its properties. He shall commence the Meeting of the Board of Trustees under the direction of the president and maintain regular record of all the proceedings of such Meetings. All correspondence and all financial statements and returns required in connection with management of the Trust will be carried out and prepared by the secretary. The Chief Trustee shall be nominate any body. He shall be responsible for the Board of Trust. In any case, two Trustee shall be dispose the secretary.
- (c) **Treasurer :** The Treasurer shall receive and disburse, in consultation with the Chief Trustee all the moneys of the Trust and maintain or cause to be maintained proper accounts of the same. All legacies, donations and subscriptions shall be paid to the treasurer whose receipt will be valid and binding on the Trust.

In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution, shall under no circumstances be distributed among the Trustee, but shall be transferred to

another charitable Trust, society, association or institutions whose objects are similar to those of this Trust which enjoys recognition under section 80(h) of the Income Tax Act 1961 that other clauses of the principal Deed shall remain. That this amended and modified principal Deed shall remain in full force and effect.

8- The Chief Trustee shall open account in the name of the Trust in a bank and deposit therein all moneys payable to receivable by them by virtue of these presents and shall keep and maintain or shall cause to be kept and maintained proper books of accounts subject to audit by a Chartered Accountant. All transactions in bank shall be operated on by cheques or cash to be signed by the Chief Trustee.

9- The Trustee shall have the power to amend, alter or rescind any of the provisions of the Trust in a manner not inconsistent with the Objectives of the Trust and to interpret their meaning whatever the Rules and Regulations framed do not cover any emergency or is ambiguous provided that such change or interpretation do not conflict with the Aim and Objectives of the Trust. If any difficulty arises in giving effect to the provisions of the "Deed of Trust" the majority of the Trustees may, by circulation or otherwise, make such provision not inconsistent with the Deed of the Trust as appears to be necessary or expedient for removing the difficulty.

10- The Office of the Trustee shall be honorary but they are entitled to draw such allowance as are prescribed by Board for carrying out their duties.

11-

(a) Any Trustee who becomes bankrupt, lunatic convicted of a criminal offence involving, moral turpitude or neglects to take interest continuously for a period of more than four months, shall cease to be a Trustee. However the final decision taken in these regard by the Chief Trustee would be binding.

(b) Any of the Trustees may retire on given Notice of one calendar month in writing of his intentions to do so.

(c) After death of Chief Trustee shall be nominate his nominee and other Trustee.

12- (a) The Trustee are wholly indemnified against any expenses losses incurred or suffered or payments made by them in administration of the Trust and such expenses losses and payments shall be borne by the Trust and none of the Trustees shall in manner be personally liable to or responsible for the same.

(b) The Trustees may reimburse themselves or pay and discharge out of the said Trust Properties, all expenses incurred for the execution of the objects of the Trust and in exercise of the powers vested in them.






